4. First-aid Measures**4.1 Description of First Aid Measures**

AFTER INHALATION: Give oxygen or artificial respiration if needed. Remove person to fresh air. If signs/symptoms continue, get medical attention.

AFTER SKIN CONTACT: Cover wound with sterile dressing. Immediate medical treatment is necessary as untreated wounds from corrosion of the skin heal slowly and with difficulty. In case of contact, immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. If skin irritation persists, call a physician.

AFTER EYE CONTACT: Rinse thoroughly with plenty of water for at least 15 minutes and consult a physician. Small amounts splashed into eyes can cause irreversible tissue damage and blindness.
