SECTION 4: First-aid Measures

4.1 Description of First Aid Measures

GENERAL NOTES: Show this safety data sheet to the doctor in attendance.

AFTER INHALATION: Move to fresh air. Provide fresh air, rest and warmth. Call a physician immediately. Give oxygen or artificial respiration if needed. When risk of unconsciousness, place and transport the victim in secured recovery position. **AFTER SKIN CONTACT:** Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. 7.1 Precautions for safe handling

Keep containers dry and tightly closed to avoid moisture absorption and contamination. Take necessary action to avoid static electricity discharge (which might cause ignition of organic vapours). Prevent the creation of flammable or explosive concentrations of vapour in air and avoid vapour concentration higher than the occupational exposure limits. Electrical equipment should be protected to the appropriate standard. Preparation may charge electrostatically: always use earthing leads when transferring from one container to another.
