**5.3 Advice for firefighters**

Flash back possible over considerable distance. In the event of fire, wear self-contained breathing apparatus. Do not use a solid water stream as it may scatter and spread fire. **INSTRUCTIONS FOR SAFE HANDLING:** Take necessary action to avoid static electricity discharge (which might cause ignition of organic vapours). Vapours may form explosive mixtures with air.
